For events held on or after October 7, 2015 the following changes were approved by the Board:

1. Best Junior Handler must be offered if the club is offering Junior Showmanship classes.
2. Clubs may offer Reserve Best Junior Handler. Such an award must be listed in the premium list and the ribbon/rosette color is Rose & Gray. Awarding Reserve Best Junior Handler will follow the format of awarding Reserve Winners in the conformation breed competition. After awarding Best Junior Handler, the second place winner from the class that

the Best Junior Handler winner was in is to return to the ring to compete for Reserve Best Junior Handler.

I have heard mixed reviews from Juniors on this change. Opinions from our club members are welcome.

Last, we need to discuss and vote on the change below.

Vote on the proposed amendment to **Chapter 2, Sections 1-16**, of the *Rules Applying to Dog Shows – Making Application to Hold a Dog Show*, in which with the deletion of Section 2, brings the Rules into compliance with current operating procedures. Changes to Section 3, requires clubs to (1) hold events in their territory to retain exclusivity and (2) only provides exclusivity for a defined period of time surrounding the show date. Additionally, an appeals process is outlined for clubs that believe permission to hold a show within another club's territory has been unreasonably withheld. The deletion of Sections 5-7 removes outdated and repetitive language. Sections 8-16 will be renumbered. Changes to new Section 14 allows clubs to have digital rather than paper copies of documents at events.
