## Delegate's Report SEPTEMBER 7, 2014



It has been suggested that the rules be changed to eliminate the necessity of host letters. They are trying to allow some elasticity for using a venue and prevent a club from holding a venue hostage. Some feel there might a valid reason for denying a club use of a venue.

It was also suggested a club give out stickers to spectators to wear, saying some verbiage such as "I went to the dog show". When they stop at a store, or out to eat, they would be advertising for the show.

The Judges approval process is being reviewed.

The Houston cluster announced they did an electronic premium and it didn't affect their entry much. They are still working on the procedure for catalogs, etc. Everyone is trying to replace printed with electronic. One problem is that some areas do not have WIFI or internet service.

One club said they have a kimtag on all their advertising, banners, etc. that takes you directly to their website. One club is going to have it go to the show layout.

There was some discussion about judges who sign multiple contracts to judge the same breeds with dates that are too close. If they can't fulfill one of the contracts, some felt the judge should be charged whatever expense is incurred to hire a judge to judge those breeds.
